The Isanti County Board of Adjustment will hold a public hearing on **Thursday, November 10, 2016** at 9:00 a.m. in the County Board Room of the Isanti County Government Center, 555 - 18th Avenue SW, Cambridge, MN 55008 to consider the following requests:

1. The request of Randy Larson, 2800 – 369th Avenue NE, Grandy, MN 55029, to construct an addition to the dwelling with less than the required setback from the center line of a County Road. Legal description is pt of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 3, Township 36, Range 23, Cambridge Township.
2. The request of Mark & Rhonda Witter, 40563 Highway 47 NW, Dalbo, MN 55017, to construct an addition with less than the required setback from the right of way of State Highway 47 and to construct a covered porch with less than the required setback and with less than the required setback from the right of way of State Highway 47.
